1. Regular giving to Christ Church:

a) The Parish Giving Scheme (PGS) is our preferred method for regular giving. It is the most used method in Christ Church and is widely used by parishes across the country. In this, you pay through a direct debit to the scheme on the first of the month and they send both the gift and tax relief (where applicable) to us promptly after that. There is no charge to the church or to you for the scheme.

For more information please collect a brown envelope labelled "For Regular Giving" from the wall display opposite the pigeon holes in church. In the envelope you will find their Gift Form that must be completed and sent to PGS to join the scheme. Please don't use the form on page 3 of this leaflet. Their website is (www.parishgivingscheme.org.uk).

If you wish to change the amount of your giving in future, you can do this by phone (01452 835595) or e-mail to PGS. Their contact details can be found on any PGS correspondence.

b) Give As You Earn: Please contact your employer.

c) Other schemes: We can also work with schemes such as CAF (Charities Aid Foundation). Please contact them about regular giving. When you use their vouchers please make them payable to "Christ Church Winchester".

2. Other regular giving:

You can give to Christ Church (if you do not wish to use PGS) or to a project or organisation connected with Christ Church (restricted giving) by standing order. Please fill in the "Standing Order to Christ Church" form on page 3 of this leaflet. Please also use this form for standing order changes.

3. One-off giving:

You can make single donations (whether by cash, cheque or via your bank account) to Christ Church or to a particular project or organisation (restricted giving) connected with us. Please fill in the "Single Gift to Christ Church" form on page 4 of this leaflet.

4. Legacy:

Please consider giving to Christ Church when you make or change your will.
